

- 1 The above unaudited financial results have been reviewed by the Audit Committee and approved by the Board of Directors at their meetings held on 14th February, 2019. The Limited Review for the quarter and nine months ended 31 December 2018 has been carried out by the Statutory Auditors, as required under Regulation 33 of SEBI (LODR) Regulations, 2015.
- 2 The Company adopted Indian Accounting Standard ("Ind-As") Prescribed under section 133 of the Companies Act, 2013 read with the relevant Rules issued thereunder from 1st April 2017 and accordingly these unaudited financial results have been prepared in accordance with the recognition and measurement principles laid down in Ind-AS 34(interim Financial Reporting" and the other accounting principles generally accepted in India.
- 3 IND AS 115 Revenue from Contracts with Customers, has been recently introduced effective April 1, 2018 and its application did not have significant impact on recognition and measurement of revenue and related items in the financial results including the retained earnings as at 1 April, 2018.
- 4 We have taken fair value(book value) of Un-quoted Equity Shares as on 31st March 2018 in Last Qtr ended Sept 2018. So due to this there is increase in Comprehensive Income from June Qtr to Rs 139.55 lakh in Last Qtr ended Sept 2018.
- 5 As the company has only one operating segment i.e, Trading Business. Hence segment reporting under Ind AS 108 is not required.
The Statutory Auditors of the Company have issued an unqualified review report on the unaudited financial results for the quarter and nine months ended 31 December 2018.
- 7 The figure of the previous period has been regrouped/ reclassified, wherever necessary, to conform to the classification for the quarter and Nine Month ended 31 December 2018.
